Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 5. Pre-bid meeting shall not be held.
- 6. Sealed or electronic bids must be submitted to the office **Sundarbazar Municipality,Lamjung** by hand/courier or throup PPMO website <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 on 10 August 2021. Bids received after this deadline will be rejected
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **10** August 2021 14:00 at the office **Sundarbazar Municipality,Lamjung**. Bids must be valid for a period of **120 days** after bid opening and must be accompan by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **as mention below** which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of last date.
- 9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
