- Sealed or electronic bids must be submitted to the office **Sundarbazar Municipality, Lamjung** by hand/courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 on **6<sup>th</sup> June 2021**. Bids received after this deadline will be rejected.
- The bidswill be opened in the presence of Bidders' representatives who choose to attend at **6<sup>th</sup> June 2021** at the office of **Sundarbazar Municipality, Lamjung**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **as mentioned below** which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
